If you know of any Honorary Wild Life Ranger who has demonstrated excellent voluntary contributions in wildlife protection and conservation, kindly nominate him/her for the Sarawak Chief Minister's Award for Outstanding Honorary Wild Life Ranger! This is a great opportunity to appreciate and support someone who has unselfishly volunteered time and efforts to be the government's agent of conservation working in sometimes difficult landscapes. General Criteria:

- Nominees must be current Honorary Wild Life Rangers, who have no past record of violating the provisions of the National Parks and Nature Reserves Ordinance 1998 and Wild Life Protection Ordinance 1998 for the last two years.

Specific Criteria:

- Nominees demonstrate outstanding creativity and /or passion and dedication in wildlife conservation.
- Nominees have made significant contributions in their limited time frames.
